### SUBJECT: DISCLOSURE OF FINANCIAL INTERESTS BY MEMBERS OF THE SENIOR MANAGEMENT SERVICE – 2019/20 DISCLOSURE PERIOD

The purpose of this circular is to remind Heads of Department and Provincial Administrations that Members of the Senior Management Service (SMS members) are required to disclose their financial interests by **30 April 2020**, in compliance with regulations 18(1) and (2) of the Public Service Regulations, 2016.

The Department of Public Service and Administration (DPSA) circular number 14 of 2020, dated 26/03/2020 (Deviation: Compulsory reporting to be submitted during the nation-wide lockdown) has no bearing on the due date for the disclosure of financial interests by SMS members.

There is **no extension** in this regard. The eDisclosure system will remain open until **30 April 2020**. The system is accessible outside the government network using the URL: [www.edisclosure.gov.za](http://www.edisclosure.gov.za) using any mobile device. Kindly ensure that all SMS members receive this information.


