**TO THE HEADS OF ALL DEPARTMENTS AND PROVINCIAL ADMINISTRATIONS**

**REVISION OF SUBSISTENCE ALLOWANCE TARIFFS: ARGENTINA, CROATIA, HUNGARY, ROMANIA, PAKISTAN, MEXICO, UGANDA, USA, SWITZERLAND AND ZIMBABWE**

1. The Minister for the Public Service and Administration has, in terms of section 3(3) of the Public Service Act, 1994, as amended, read with Part V/E. 2(a) of the Public Service Regulations, 2001, made a determination that with effect from 01 September 2006, the special daily allowances for official visits to the above-mentioned countries be revised as contained in the attached Annexure. The Financial Manual for the calculation and the application of the special daily allowances for official visits abroad will be amended in due course.
2. Treasury approval under reference SM 25/70 dated 08 August 2006 was obtained for the expenses resulting from the above recommendation, on condition that the expenditure be met from the various existing departmental budgets.
