RESETTLEMENT EXPENDITURE: NEW SCHOOL BOOKS, UNIFORMS AND RELATED COSTS

Based on the Consumer Price Index (CPI): Clothing and Footwear as on 1 October 2009, the Minister for the Public Service and Administration has determined that the amount payable to compensate transferred employees for new school books, uniforms and related costs be increased from R 978.00 to R 987.00 with effect from 1 January 2010. The attached table refers.

National Treasury has granted approval under reference SM 5P dated 15 December 2009 in terms of section 5(3) of the Public Service Act, 1994, as amended, for the of the revised tariffs. However, the resulting additional expenditure incurred as a result of this approval will have to be met from existing budgets of affected departments.
