RESOLUTION NO 6 OF 2008

**AMENDMENT TO RESOLUTION 2 OF 2008 (EXTENSION OF TIMEFRAMES): OSD
NEGOTIATIONS AT SECTORAL LEVEL**

Noting that:

1. Clause 4.16 of Resolution 1 of 2007 states that "All negotiation processes must be finalized 2 months prior to the implementation date. In the event that the negotiations process is not concluded, the matter will be referred to the PSCBC for finalization within 7 days of the expiry of the 2 months prior to the date of implementation".
2. Clause 4.1.2 of Resolution 2 of 2008 states that "Council resolves to allow PHSDSBC to finalize the occupation specific salary structure for Social Workers by 30 April 2008.
3. The Public Health and Social Development Sectoral Bargaining Council (PHSDSBC) is in a process of finalizing the revised salary structure for the identified occupations in the health and social development sectors, and has requested for an extension.

Agreement

4. Council resolves that PHSDSBC finalize the occupation specific salary structure for **Social Workers** by 31 July 2008.

Scope

5. This agreement binds:
 - (a) The employer,
 - (b) the employees of the employer who are members of the trade union parties to this agreement; and
 - (c) the employees of the employer who are not members of any trade union parties to this agreement, but who fall within the registered scope of Council.

7. If there is a dispute about the interpretation or application of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.





