RESOLUTION NO 9 OF 2008

**EXTENSION OF TIMEFRAMES: OSD FOR NEGOTIATIONS AT SECTORAL LEVEL
AND PROCESS TO DEVELOP MINIMUM SERVICE LEVEL AGREEMENT**

Noting:

1. Clause 4 of Resolution 4 of 2008 extends the timeframe for PHSDSBC to finalize the occupation specific salary structure in terms of Resolution 1 of 2007 clause 4.14.1.3 for Medical Officers, Medical Specialists, Dentists, Dental Specialists, Pharmacologists, Pharmacists and Emergency Care Practitioners, to 31 July 2008.
2. Clause 4 of Resolution 6 of 2008 extends the timeframe for PHSDSBC to finalize the occupation specific salary structure in terms of Resolution 1 of 2007 clause 4.14.1.5 for Social Workers, to 31 July 2008.
3. Clause 4.14.2.3 of Resolution 1 of 2007 provides that the revised salary structure for Educator Specialists- Counselors, Therapists and Psychologists shall be implemented with effect from 1 April 2008.
4. Clause 4.14.3.4 Resolution 1 of 2007 provides that the revised salary structure for Correctional Officials shall be implemented with effect from 1 July 2008.
5. That Sectoral Bargaining Councils are in a process of finalizing the revised salary structures for the above-mentioned occupations.
6. Clause 2 of Resolution 7 of 2008 extends the timeframe for finalizing the process to develop Minimum Service Level Agreement in terms Addendum 1 of Resolution 1 of 2007, to 1 August 2008.
7. That Council is in a process of finalizing the development of a Minimum Service Level Agreement.

Agreement

8. Therefore Council resolves to extend the timeframes as follows:
 - 8.1 PHSDSBC to finalize the occupation specific salary structure for Medical Officers, Medical Specialists, Dentists, Dental Specialist, Pharmacologists, Pharmacists and Emergency Care Practitioners by **30 November 2008**
 - 8.2 PHSDSBC to finalize the occupation specific salary structure for Social Workers by **31 August 2008**.
 - 8.3 ELRC to finalize the occupation specific salary structure for Educator Specialists- Counselors, Therapists and Psychologists by **31 August 2008**.
 - 8.4 GPSSBC to finalize the occupation specific salary structure for Correctional Officials by **31 August 2008**.
 - 8.5 PSCBC to finalize Minimum Service Level Agreement by **31 October 2008**

Scope

9. This agreement binds,
 - (a) the employer,
 - (b) the employees of the employer who are members of the trade union parties to this agreement; and
 - (c) the employees of the employer who are not members of any trade union parties to this agreement, but who fall within the registered scope of Council.
10. The Council will monitor the implementation of this agreement.


Dispute Resolution

11. If there is a dispute about the interpretation or application of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.







