

RESOLUTION NO 1 OF 2008⁹ M.S.

EXTENSION OF TIMEFRAMES: OSD FOR NEGOTIATIONS AT SECTORAL LEVEL

Noting:

1. Clause 8.1 of Resolution 9 of 2008 extends the timeframe for PHSDSBC to finalize the occupation specific salary structure in terms of Resolution 1 of 2007 clause 4.14.1.3 for Medical Officers, Medical Specialists, Dentists, Dental Specialists, Pharmacologists, Pharmacists and Emergency Care Practitioners, to 30 November 2008.
2. Clause 8.3 of Resolution 9 of 2008 extends the timeframe for ELRC to finalise the occupation specific salary structure in terms of Resolution 1 of 2007 clause 4.14.2.3 for Educator Specialists- Counselors, Therapists and Psychologists by 31 August 2008. On 28 August 2008, Council further agreed to extend the timeframe to the 30 November 2008.
3. Clause 8.4 of Resolution 9 of 2008 extends the timeframe for GPSSBC to finalise the occupational specific salary structure in terms of Resolution 1 of 2007 clause 4.14.3.4 for Correctional Officials by 31 August 2008. On 28 August 2008, Council further agreed to extend the timeframe to the 30 November 2008.
4. That Sectoral Bargaining Councils are in a process of finalizing the revised salary structures for the above-mentioned occupations.

Agreement

5. Therefore Council resolves to extend the timeframes as follows:
 - 5.1 PHSDSBC to finalize the occupation specific salary structure for Medical Officers, Medical Specialists, Dentists, Dental Specialist, Pharmacologists, Pharmacists and Emergency Care Practitioners by 1 March 2009.
 - 5.2 ELRC to finalize the occupation specific salary structure for Educator Specialists- Counselors, Therapists and Psychologists by 1 March 2009.
 - 5.3 GPSSBC to finalize the occupation specific salary structure for Correctional Officials by 1 March 2009.

6. This agreement binds,
 - (a) the employer,
 - (b) the employees of the employer who are members of the trade union parties to this agreement; and
 - (c) the employees of the employer who are not members of any trade union parties to this agreement, but who fall within the registered scope of Council.
7. The Council will monitor the implementation of this agreement.

Dispute Resolution

8. If there is a dispute about the interpretation or application of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.


