

## RESOLUTION NO 1 OF 2010

### AMENDMENT TO PSCBC RESOLUTION 5 OF 2009: TIMEFRAMES FOR 2010 /2011 SALARY NEGOTIATIONS

#### NOTING:

1. That Clause 3.2 of PSCBC Resolution 5 of 2009 provided a process for the salary negotiations for Financial Year 2010/ 2011.

#### OBJECTIVE

2. To amend Clause 3.2 of PSCBC Resolution 5 of 2009.

#### SCOPE

3. This agreement binds-
  - 3.1 the employer;
  - 3.2 the employees of the employer who are members of the trade union parties to this agreement; and
  - 3.3 the employees of the employer who are not members of the trade union parties to this agreement, but who fall within the registered scope of the Council.

#### PARTIES TO THE COUNCIL AGREE

4. To amend clauses: 3.2 as follows:

**"Negotiations shall be finalised by no later than 28 February 2010"**



- 6. No amendments to this Agreement shall be of force unless reduced to writing and agreed upon at the Council as a Resolution of the Council.


**DISPUTE RESOLUTION**

- 7. Disputes about the interpretation or application of this Agreement shall be dealt in accordance with the dispute resolution procedure of the Council.






