## 2. **DEFINITIONS**

#### **PART A**

#### 1. PURPOSE

The purpose of these Terms of Reference is to invite bids from service providers to provide competency-based assessment services for Senior Management Service in National and Provincial departments for the period of four (4) years.

#### 2. INTRODUCTION AND BACKGROUND

On the 23 August 2000, Cabinet approved a package of measures aimed at reforming the Senior Management Service (SMS) in the Public Service. These measures are aimed at improving the State's ability to recruit, retain and develop competent Senior Managers. Furthermore, in 2008 Cabinet recommended that competency assessments be implemented on a compulsory basis. The Department of Public Service and Administration (DPSA) has a prescribed competency assessment battery which is implemented in all National and Provincial Departments.

As part of the recruitment and developmental assessment process, the DPSA wishes to establish a panel of service providers who will assist in providing competency-based assessment services for Senior Managers in the Public Service. The panel of service providers will be sourced and accredited by the DPSA. The DPSA will establish a database containing particulars of the accredited service providers as well as areas from which they operate. The accredited service providers will be engaged by departments as and when needed.

In terms of the appointment of the panel of service providers, the DPSA will play a leading role in the bidding process that will inform the appointments. This will include, amongst others, the preparation of the bidding documents, adverts, communication related to the bidding process, the drafting of the contracts and actual contract negotiations for the appointment on the panel of accredited service providers.

#### 3. CONTRACT PERIOD

The bid will result in a panel of service providers being appointed for a period of four (4) years. The performance of the service provider will be evaluated annually against the expected performance standards which will be stipulated in the service level agreement. Please note that the assignments may vary and will not necessarily cover the entire period. Acceptance of any bid does not mean that work on an uninterrupted basis is guaranteed for the duration of the bid period. The services of each bidder must be available for a period of four (4) years.

#### 4. SCOPE OF WORK

A panel of service providers will be required to conduct assessment utilising the prescribed battery as described for members of the SMS in the Public Service. These assessments may be administered during recruitment processes for SMS candidates or for existing members of the SMS in the Public Service as part of assessments for development purposes. The scope includes the following:

- a) Conduct SMS competency assessments.
- b) Administering prescribed psychometric assessments.
- c) Analyse, interpret and prepare assessment reports.
- d) Provide feedback to candidates (this can either be face to face or telephonic).
- e) Provide feedback to the User Department in the form of a written report.
- f) Interpret the psychometric assessment results to the selection committee.
- g) Capturing assessments data on the DPSA assessment database.
- h) Provide assessments feedback during quarterly information sessions to DPSA.
- Provide an annual report to the DPSA in respect to assessments conducted for a particular financial year.
- j) Provide comprehensive assessment report at the end of the contract period.
- k) Perform all administrative and logistical processes associated with the administration of the competency assessment.

#### 5. CURRENT ASSESSMENT BATTERY

The prescribed assessment battery consists of competency assessment simulation exercises and psychometric instruments as determined by the DPSA. Considering that the DPSA is moving towards a virtual/online assessments platform, it is therefore vital that service providers have the online/virtual capacity to manage such when introduced by the DPSA.

## 6. CONFIDENTIALITY

It will be expected from the Bidder (with staff members working on Public Service assignments) to sign an Oath of Secrecy and comply with the Protection of Personal Information Act (POPIA) since the appointed Bidders will be entrusted with confidential information which may not be disclosed to other parties except when required by the relevant department.

The Bidder will ensure that all its staff members (full time and part time), or associates treat all information relating to the services as strictly confidential and adhere to all protocols as prescribed by the Health Professions Council of South Africa (HPCSA).

The Bidder will ensure that proper security procedures are implemented and maintained to restrict access of confidential information to the personnel involved in the services. Furthermore, it will also ensure that no confidential information is copied or reproduced without the department's or DPSA's prior written approval.

Copyright of the prescribed assessment battery belongs to the DPSA. Service providers are expected to protect the content and ideas as contained in the assessment battery. The assessment battery may not be used nor duplicated for assessments other than as required for the Public Service and must be returned at the end of the bid contract.

#### 7. ASSESSMENT PROCESS

## 7.1 Psychometric assessments

The psychometric assessments shall take place over a period of one day. Verbal feedback shall be provided to each candidate and department following the assessment. A compressive report shall be provided to the User Department. The service provider shall/may be required to provide the interpretation of the assessment results to the selection panel in order to make an informed decision.

## 7.2 Generic /Leadership assessment

The assessment process should preferably take place over one day. The service provider will be required to analyse the assessment and prepare an assessment report. Verbal feedback must be provided to each candidate following the assessment. A comprehensive written report outlining the assessment results must be provided to the relevant department within three working days after the assessment.

## 7.3 Capturing and report submission

All reports shall be uploaded to the DPSA database when capturing the assessment data. All assessment data shall be captured on the template provided by DPSA and submitted on the last working day of every quarter by the service provider. The service provider will also be provided with a link to submit all the annual assessment reports. The service providers will be provided with reporting templates for submitting their project close out report at the end of the contract.

## 8. TRAINING ON THE ASSESSMENT EXERCISES TO BE USED

Service providers must make themselves available for a training workshop which will be conducted by the DPSA. This workshop will encompass the necessary training in terms of administration, scoring and interpretation of the assessment exercises. Service providers will be accredited to use the prescribed assessment exercises following the training. At least two qualified staff members from each service provider must attend the training workshop. to transfer skills to their staff members and ensure that all staff that will be conducting the assessments are fully trained and accredited. The DPSA will only cover the costs of the first training workshop on the prescribed simulation exercises. **No** other costs will be covered by the DPSA for example, training on psychometric instruments that are part of the assessment battery, travel and accommodation, accreditation of the consultants or hourly rates etc.

#### 9. QUALITY ASSURANCE

DPSA reserves the right to have the validity of the documents submitted by the services provider verified.

If, as a result of the inspection or examination, DPSA decides that the services or any part thereof is defective or otherwise not in accordance with the bid and service level agreement, the department may reject such work and will notify the service provider in writing stating its reasons. The service provider will then make good the defect and ensure that rejected work complies with the bid specifications and service level agreement. If such rejection causes the service provider to incur additional costs, neither the DPSA nor the respective department will be responsible for such costs.

DPSA reserves the right to evaluate the services of service provider at any time.

#### 10. PERFORMANCE OF SERVICES

The successful service providers will exercise all reasonable skills, care and diligence in the discharge of obligations in terms of the duties allocated to them and will perform all services in accordance with the highest ethical standards consistent with their specific profession and applicable to the objectives of the Public Service.

#### 11. PAYMENTS

It should be borne in mind that individual departments have the responsibility for the payment of the services rendered and it is not the responsibility of the DPSA to settle the cost incurred by other departments.

## 12. CANCELLATION/ TERMINATION OF CONTRACT

The DPSA reserves the right to cancel any contract if the successful service provider fails to adhere to the conditions of the respective contract.

In the event of termination of the contract/service level agreement for whatever reason, the respective service provider shall deliver on demand and without the right of retention, all documents and information gained in terms of this agreement to the DPSA.

#### 13. THE ROLE OF THE DPSA

- a) The DPSA shall set norms and standards to ensure uniformity related to the following areas:
  - i. pre-determine the competency assessment price (See Annexure: B).
  - ii. provide competency assessments price structure and review of the fees payable for the consultancy service rendered by an accredited service provider and pricing shall be reviewed in 2027 and 2029.
  - iii. the turnaround times that should be adhered to, by the stakeholder to ensure compliance with standards set in the legal framework.
  - iv. the minimum standards of monthly/quarterly reports that the accredited service providers must submit to the DPSA and Departments.
  - v. the renewal of appointments on the panel of accredited service providers upon expiry of the term of appointment, if required.
- b) The DPSA shall monitor and evaluate the application of competency-based assessments, as well as the contracts concluded with a panel of accredited service providers through
  - i. quarterly information sharing sessions.
  - ii. annual reports from the service provider to the DPSA.
  - iii. performance review sessions.
  - iv. individual meetings with the service provider and the DPSA shall take place as and when the need arises.

## 14. THE ROLE OF THE SERVICE PROVIDER

In addition to the mentioned scope of work outlined in paragraph 4, the primary role of the successful service provider is to adhere to the professional and obligatory requirements of the service level agreement.

The appointed service providers shall be required to sign a service level agreement, which will cover expectations in greater detail.

#### **PART B**

#### 1. EVALUATION OF BIDS AND CRITERIA FOR EVALUATION

The evaluation of bids will be conducted in three phases (mandatory requirements, functional and price and specific goals).

## 1.1 Phase 1: Mandatory requirements

During this phase bidders' response will be evaluated based on the mandatory requirement. These are the documents to be submitted for evaluation. Bidders' must submit all required documents indicated within the bid document at the closing date and time of the bid. Bidders who fail to comply with all the mandatory criteria will be disqualified. A Bidder submits a single response/proposal to the Bid. The Bidder must respond fully to the request for information noted in the Bid. As a minimum, each item must be responded to as prescribed. (Also, refer to the framework provided for responses elsewhere in the Bid). A Bidder may provide additional information on relevant items.

The following must also be attached in the bid (Mandatory requirements)

- The company profile detailing infrastructure, experience, offices and capacity and track record.
- (ii) Fully completed Annexure A.
- (iii) Signed price schedule (Annexure B).
- (iv) Abridged CVs (a maximum of 2 pages) of assessors including proof of valid and certified qualifications and proof of registration documents with the professional body, CPP and Giotto certificates.
- (v) Reference letter(s) from previous clients written on the referee letter head, indicating amount and period.
- (vi) Proof of registration on the Central Supplier Database with National Treasury. NB: Prospective bidders responding to this bid must be registered as a Service Provider on the Central Supplier Database (CSD). If a Service Provider is not registered on the CSD, such Provider should complete the registration process prior to submitting a proposal. Refer to <a href="http://secure.csd.gov.za">http://secure.csd.gov.za</a> to register as a Service Provider. Ensure that all

documentation on the database is updated and valid. No bid will be awarded to a Supplier/Service Provider who has not registered on the CSD.

**Note**: all personal information provided will be used in accordance with the provisions of the Protection of Personal Information Act no 4 of 2013.

Note: Bidders who fail to comply with the mandatory requirements will be disqualified and not considered for any further evaluation.

## 1.2 Phase 2: Functionality evaluation

The DPSA will use the information submitted by the service provider to evaluate the proposals against the following criteria.

Service providers will be evaluated on functionality using the below mentioned criteria. The minimum qualifying threshold on functionality is **80 points**. All bidders who score less than **80 points out of 100 points** will not be considered. Evaluation points will be allocated using the table below.

## 1.3 Summary of the functionality evaluation criteria

## (a) Capacity of the service provider

Service Providers who have the capacity to provide competency assessments services and qualified human capacity (full time personnel/associates/ representatives) in all nine provinces will score higher in respect to criterion 1. The DPSA may conduct site visits to shortlisted service providers if deemed necessary.

These visits will be considered as part of the Bidder's capacity to provide the quality of service and operations necessary to support the DPSA's requirements.

(b) Experience of service providers in conducting online/virtual competency assessments

Proven experience as <u>a company</u> in respect to conducting online/virtual competency assessments. A service provider must have proven experience in conducting online/virtual competency assessments.

(c) Experience of service provider in conducting competency-based assessments at a senior and executive managerial level.

Proven experience as a company in respect to the conducting of competency-based assessments at senior and executive management level.

## (d) Qualification of staff

A maximum of two pages Curriculum Vitae (CVs) and valid registration information with the HPCSA of all staff members who will be involved in the process must be submitted (information on the CVs must be in line with page 28, **Annexure A** of this ToR). Service Providers are required to ensure that all information pertaining to qualifications and professional registrations have been verified. Should it be found that a Service Provider has not been honest in respect to its personnel, such a Bidder may be disqualified. The DPSA shall accept that the certified copies of the professional registration and qualifications are true and have been verified by the service provider.

All staff who are involved in the administration, scoring and interpretation of results regarding competency assessment as well as those who will be giving feedback to the candidates and writing the reports must be appropriately qualified.

#### i. Level 1

This level of staff will be suitable to assess candidates for Director and Chief Director positions. This level of staff must as a minimum, be registered Psychometrists. Experience with regard to senior managerial assessments (5-9 years) will be a strong recommendation.

#### ii. Level 2

This level of staff will be suitable to assess candidates for Deputy Director-General and Director-General positions. This level of staff must be registered as Psychologists as a minimum requirement. Extensive experience with regard to senior and executive managerial assessments (5-9 years) will be a strong recommendation.

The service provider will notify DPSA's Chief Director: Human Resource Development in advance of any change in the personnel as identified in the Bid documents. Written approval must be obtained prior to the utilisation of such personnel. The personal particulars and curriculum vitae of any new personnel must be submitted for approval. A telephonic or virtual interview may be conducted with any new personnel submitted. Service providers must ensure that any new staff members are properly trained in the administration, scoring and interpretation of the assessment tools and report writing thereof.

In the event that the service provider fails to notify the DPSA as contemplated above, the department shall not be held liable for costs incurred by the service provider as a result.

(e) Experience of bidder in administering the psychometric assessments, interpretation and feedback of the assessment results (e.g., CPP, Giotto, and emotional intelligence).

The bidder must indicate the number of years in administering the psychometric assessments and the names of clients whom these instruments were administered to.

(f) Experience in the continuous development and maintenance of competency assessment tools.

Proven experience as a company in respect to the conducting of research on competency assessments. Indicate the number of years' experience in this regard under paragraph 9 of **Annexure A**.

## (g) Track record and references

The Bidder(s) must, to the satisfaction of the DPSA demonstrate that they have successfully conducted competency assessments with organizations of similar size as the Departments and provinces. For this purpose, the Bidder must provide information and references for current and past implementation and maintenance of competency-based assessments. The size, industry and products of these customers must be described as well as the types of services provided. The Bidders should include a summary of all recent reviews by its customers and should note the number and type of non-compliance with performance levels that were identified.

## 1.3 Phase 3: Price and Specific goals

Only service providers that score points which exceed the minimum threshold provided on functionality will be evaluated further. The bids will be evaluated on 80/20 principle with 80 points being allocated for price and 20 points allocated for specific goals. In terms of the DPSA Supply Chain Management Policy, specific goal points are allocated for a rand value of above R2,000.00.

#### (a) Pricing schedule and structure requirements

The price structure for the DPSA SMS competency assessment battery and Cognitive Process Profile (CPP), Giotto and emotional intelligence (15FQ+) has been determined by the DPSA. The pricing schedule (see Annexure B attached) must be submitted together with the bid. The pricing schedule provided in this bid forms an integral part of the bid document and bidders must ensure that it is signed without changing the structure thereof. Bidders are required to submit a mandatory pricing schedule as a response.

## (b) Preferential Point System

The Department will in terms of specific goals focus on persons historically disadvantaged based on race (black people), gender (women) and persons living with disabilities as well as categories of persons being youth referenced in the Preferential Procurement Policy Framework Act and its associated regulations. The Preference point system will therefore be based on Price and the consolidated points scored for the four respective goals. Responsive bids will be adjudicated by the Department on the 80/20 preference point system in terms of which points are awarded to bidders based on the formulae below:

The following formula will be used to calculate the points for price in respect of bidders:

$$Ps = 80 \left( 1 - \frac{Pt - Pmin}{Pmin} \right)$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

Points will be awarded to a bidder for attaining specific goals for the procurement initiative. A maximum of 20 points may be awarded to a bidder who meets the criteria for the four specific goals from a preference point perspective. For this Bid, the maximum number of points that could be allocated are indicated in the table below:

- 10.2.2. as is necessary for the purposes of this Agreement and the Services;
- 10.2.3. for maintaining its internal administrative processes, including quality, risk, client or vendor management processes;
- 10.2.4. for internal business-related purposes; and
- 10.2.5 in accordance with the lawful Purpose and reasonable instructions of DPSA as the Responsible Party

#### 11 AUDITS

- 11.1 Audit Rights:
- 11.1.1 The Service Provider will maintain a complete audit trail of financial and non-financial transactions resulting from the Agreement. The Service Provider will provide to DPSA, its internal or external auditors, inspectors and regulators access at all reasonable times to such facility or part of a facility at which either the Service Provider is providing the Deliverables and/or Services, to Service Provider Personnel, and to equipment, software, personnel, data, records and

documentation relating to the Deliverables and/or Services for the purpose of performing audits and inspections of the Service Provider to: (i) verify the accuracy of the Service Provider's Fees and invoices; (ii) verify the accuracy of payments by or credits from the Service Provider; (iii) verify the accuracy of price changes to the extent such changes are determined by reference to Service Provider's costs or changes thereto; (v) examine the Service Provider's performance of the Services or Deliverables, including verifying compliance with the industry standards; (vi) verify compliance with the terms of the Agreement; (vii) satisfy the requirements of any Applicable Law;

- 11.1.2 DPSA reserves the right to appoint a third party to perform an audit under this Clause.
- 11.1.3 The Service Provider will provide to the auditors, inspectors and regulators such assistance as they may require. In the case of audits, DPSA's audits will not unreasonably interfere with the Service Provider's normal course of business and will comply with the Service Provider's reasonable confidentiality requirements.
- 11.1.4 Unless DPSA has a good faith suspicion of fraud, DPSA will provide the Service Provider with reasonable notice for audits.
- 11.1.5 All costs incurred by DPSA in performing audits of the Service Provider will be borne by DPSA unless any such audit reveals a material inadequacy or material deficiency in respect of the Services including compliance with the relevant Applicable Laws, in which event the cost of such audit will be borne by Service Provider.
- 11.1.6 If an audit reveals an overcharge, the Service Provider will promptly refund the overcharge plus interest at Repo Rate, from the date of payment of the overcharge through the date the overcharge is refunded by Service Provider.

## 12. WARRANTIES

- 12.1. The Service Provider hereby represents and warrants to DPSA that-
- 12.1.1. this Agreement has been duly authorised and executed by it and constitutes a legal, valid and binding set of obligations on it;
- 12.1.2. it is acting as a principal and not as an agent of an undisclosed principal;
- 12.1.3. the execution and performance of the terms and conditions of this Agreement does not constitute a violation of any statute, judgment, order, decree or regulation or rule of any court, competent authority or arbitrator or competent jurisdiction applicable or relating to the Service Provider, its assets or its

- business, or its memorandum of incorporation or any other documents or any binding obligation, contract or agreement to which it is a party or by which it or its assets are bound;
- 12.1.4. it will provide the Services in a cost-effective manner, thereby ensuring that no unnecessary or extraordinary costs are incurred and passed on to DPSA;
- 12.1.5. it will have the requisite insurance to cover for professional liability claims (to the extent that it may be applicable), that may be instituted against it;
- 12.1.6. it has the necessary resources, skills and experience to render the Service and/or deliver the Deliverables to DPSA; and
- 12.1.7. it is expressly agreed between the Parties that each warranty and representation given by the Service Provider in this Agreement is material to this Agreement and induced DPSA to conclude this Agreement.
- 12.2. The provisions of this Clause shall survive the termination of this Agreement.

#### 13 INDEMNITY

- 13.1 Without in any way detracting from DPSA's rights in terms of this Agreement, the Service Provider hereby indemnifies DPSA from any and all losses which may be suffered as a result of any breach of the warranties including the provisions of this Agreement by the Service Provider or Service Provider personnel.
- 13.2 In addition to any remedy available to DPSA, the Service Provider agrees to indemnify in full an on demand and to keep DPSA so indemnified from and against all claims, demands, actions, proceedings and losses, which are made or brought against or incurred or suffered by DPSA resulting from any action arising from the Service Provider's breach of any obligation with respect to confidential information and/or personal information.
- 13.3. The Service Provider indemnifies the DPSA against any claims or court actions, including all legal costs in respect thereof, that may be instituted by any person against the DPSA arising out of any act, omission or default on the part of the Service Provider or, any person performing work on behalf of the Service Provider, in the provision of services under the Agreement.

#### 14. BREACH

If a Party is in default or breach of any obligation which arises in terms of the Agreement and that defaulting Party fails to remedy such default or breach within 7 working days after receipt of a written notice given by the aggrieved Party calling upon the defaulting Party to remedy such default or breach, then the aggrieved Party may, without prejudice to any other rights which it may have in terms hereof or at law—

- (a) claim specific performance;
- (b) cancel the Agreement, such cancellation to be effective immediately on receipt by the defaulting Party of a written notice to that effect; or
- (c) claim any money due and payable in terms of the Agreement and claim damages from the defaulting Party.

## 15. INDEPENDENT CONTRACTOR

The Service Provider is employed as an independent contractor and not as an agent of the DPSA and has no authority to bind or represent the DPSA in any matter.

## 16. GOOD FAITH AND REASONABLENESS

In their dealings with each other for purposes of the Agreement, the Parties-

- (a) undertake to act in good faith and reasonably; and
- (b) warrant that they shall not do anything or shall refrain from doing anything that might prejudice or detract from the rights or obligations of each other.

## 17. CONFLICT OF INTEREST

- 17.1 Neither the Service Provider nor their staff shall engage in any activity which conflict with or could potentially conflict with the services to be provided in terms of the Agreement.
- 17.2 The Service Provider shall notify the DPSA immediately of any activities or circumstances which give rise to or could potentially give rise to such conflict of interest and shall inform the DPSA how the Service Provider intends dealing with such conflict.

#### 18. FORCE MAJEURE

- 18.1 Force majeure shall be considered to be circumstances where the performance of any obligation in terms of the Agreement are suspended or postponed by-
  - (a) strikes or lock-outs or any combination thereof by employees of either of the Parties:
  - (b) war or civil commotion;
  - (c) any cause, except as may otherwise be provided for in the Agreement, beyond the reasonable control of either of the Parties; and
  - (d) any natural disaster.
- 18.2 If the completion of any obligation be delayed as a result of *force majeure*, the Party who is unable to perform its obligation shall, within 7 working days of the occurrence of such *force majeure*, give notice thereof in writing to the other Party and request an extension of time in which to comply with its obligation. On receipt of such notice and supporting particulars of the claim, the other Party may in writing grant an extension of time as may be justified.
- 18.3 The Party who is incapable of performing its obligation shall not be liable for any such claim which the other Party may have as a result of such obligation not being performed provided that the reason why it cannot perform its obligation is due to *force majeure* and provided further that the notice referred to in 18.2 has been duly delivered.
- 18.4 In the event of *force majeure* continuing for a period of 7 working days, either Party shall be entitled to terminate the Agreement by written notice to the other Party and without any Party incurring any liability to the other Party.

## 19. TERMINATION

## 19.1. Termination for cause by DPSA

19.1.1. DPSA may, by giving notice to the Service Provider, terminate this Agreement or rendering of the Services in whole or part, as of a date set out in the notice of termination, in the event that the Service Provider-

- 19.1.1.1. breaches the confidentiality provisions of this Agreement;
- 19.1.1.2. breaches applicable laws;
- 19.1.1.3. is found guilty of an offence in terms of applicable laws;
- 19.1.1.4. commits an act of insolvency as defined in the Insolvency Act, 1936 (Act No. 24 of 1936) or is placed under provisional liquidation or under business rescue proceedings or is finally liquidated;
- 19.1.1.5. commits an act of professional misconduct or professional or technical incompetence, which is substantial and serious; or
- 19.1.1.6. commits or participates in any unlawful, dishonest or unethical act in executing this Agreement.
- 19.1.2. DPSA shall have no liability to the Service Provider with respect to a termination under this clause.

## 19.2. Termination Upon Sale, Acquisition Merger or Change of Control

- 19.2.1. In the event of a sale, acquisition, merger, or other change of control of the Service Provider (a "Change Event") where such Change Event is achieved, directly or indirectly, in a single transaction or series of related transactions, or in the event of a sale of all or substantially of all the assets of the Service Provider in a single or series of related transaction, then the Service Provider shall notify DPSA of such Change Event within ten (10) working days after the Change Event is achieved.
- 19.2.2. No sale, acquisition, merger or other change of control shall be effective against and legally binding on DPSA if the Service Provider failed to notify DPSA, as required by clause 19.2.1 above.
- 19.2.3. DPSA may terminate this Agreement, at any time after being notified by the Service Provider of the Change Event, by giving the Service Provider thirty (30)

- days written notice designating a date upon which such termination shall become effective.
- 19.2.4. In the event that the Service Provider fails to notify DPSA, as required by clause 19.2.1 above, then DPSA may upon discovery of the Change Event terminate the Agreement by giving the Service Provider (30) days written notice and designating a date upon which such termination shall be effective.
- 19.2.5. DPSA shall have no liability to the Service Provider with respect to termination of the Agreement on terms of this clause.
- 19.2.6. "Control" in terms of this clause means, with regard to any entity, the right or power to dictate the management of and otherwise control such by entity by any of the following:
  - 19.2.6.1. holding directly or indirectly the majority of the issued share capital stock (or other ownership interest if not a company) of such entity ordinarily having voting rights.
  - 19.2.6.2. controlling the majority of the voting rights in such entity; or
  - 19.2.6.3. having the right to appoint or remove directors holding a majority of the voting rights at meetings of the board of directors of such entity.
- 19.2.7. Any termination of this Agreement pursuant to the provisions of this clause shall be without prejudice to any prior claim, which either Party may have.
- 19.2.8 The DPSA may terminate the Agreement without prejudice to any of its rights upon the occurrence of any of the following:
  - (a) on commencement of any action for the dissolution and/or liquidation of the Service Provider, except for purposes of an amalgamation or restructuring approved in advance by the DPSA;
  - (b) the Service Provider receives a court order to be placed under judicial management, business rescue or to commence liquidation procedures that is not withdrawn or struck out within five working days;
  - (c) the Service Provider informs the DPSA that it intends to cease performing its obligations in terms of the Agreement;

- (d) the Service Provider informs the DPSA that it is incapable of completing the Services.
- 19.2.9. The Service Provider shall receive remuneration for the services provided to the satisfaction of the DPSA up to the date of termination of the project.
- 19.2.10. Termination of the Agreement shall relieve the DPSA and the Service Provider of their respective obligations in terms of the Agreement.
- 19.2.11. The Service Provider shall not be entitled to advance a right of retention or any similar right if the Agreement is terminated in terms of this clause.

## 20. GENERAL TERMS AND CONDITIONS

## 20.1 WHOLE AGREEMENT AND AMENDMENT

This Agreement constitutes the whole of the Agreement between the Parties relating to the subject matter hereof and no amendment, alteration, addition, variation or consensual cancellation will be of any force or effect unless reduced to writing and signed by the Parties hereto or their duly Authorised Representatives. Any document executed by the Parties purporting to amend, substitute or revoke this Agreement or any part hereof, shall be titled an "Addendum" to the applicable Service Agreement and assigned a sequential letter to be included in the title.

## 20.2 INTERPRETATION OF AGREEMENT

The law of the Republic of South Africa shall govern the interpretation of the Agreement.

## 20.3 NO ASSIGNMENT WITHOUT CONSENT

The Service Provider shall not be entitled to assign, cede, sub-contract, delegate or in any other manner transfer any benefit, rights and/or obligations in terms of this Agreement, without the prior written consent of DPSA which consent shall if approved by DPSA in its sole discretion, be in compliance with the provisions of the PFMA and DPSA's procurement policies and procedures.

## 20.4 ADVERTISING AND MARKETING

The Service Provider shall not make or issue any formal or informal announcement (with the exception of Authority announcements), advertisement or statement to the press in connection with this Agreement or otherwise disclose the existence of this Agreement or the subject matter thereof to any other person without the prior written consent of DPSA.

## 20.5 JURISDICTION OF COURTS

If any legal proceedings arise from the provisions of the Agreement, both Parties submit to the jurisdiction of the courts of the Republic of South Africa.

## 20.6 ENTIRE CONTRACT

The Agreement and the Annexures attached hereto constitute the entire contract between the Parties

## 20.7 VARIATION

No amendment, alteration, addition or suspension of any provision of the Agreement shall be of any force, unless reduced to writing and signed by both Parties.

## 20.8 WAIVER

No waiver of any right in terms of the Agreement shall be binding for any purpose unless expressed in writing and signed by the Party concerned and such waiver shall be effective only in the specific instance and for the purpose given. No failure or delay on the part of either Party in exercising any right precludes any other or further exercise thereof or the exercise of any other right.

## 20.9 CESSION

A Party may not cede any right or obligation in terms of the Agreement to another person without the other Party's written consent.

## 20.10 INVALID PROVISIONS

If any provision of the Agreement contravenes any provision of the law, that provision shall be deemed to be void or the scope of the provision shall be deemed to have been limited to exclude such contravention, provided that if any Party—

- (a) can establish in a court of law that it is adversely affected or prejudiced thereby; or
- (b) unsuccessfully relies on that provision in any legal proceedings, that Party may terminate the Agreement immediately.

## 20.11 INTERVENING CHANGES IN LAW

If any change in the law renders any material provision of the Agreement illegal or void, either Party may terminate the Agreement immediately.

## 20.12 SEVERABILITY

If any provision of the Agreement is or becomes invalid or unenforceable, such provision shall be divisible and be regarded as *pro non scripto* and the remainder of the Agreement shall be regarded as valid and binding unless materially affected.

## 21. COSTS

Each party shall bear and pay its own costs of or incidental to the drafting, preparation and execution of this Agreement.

## 22. AUTHORISED SIGNATORIES

- 22.1 The Parties agree that this Agreement and any contract document concluded in terms hereof shall not be valid unless signed by all authorised signatories of DPSA.
- 22.2 This Agreement is signed by the Parties on the dates and at the places indicated below.
- 22.3 This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same Agreement as at the date of signature of the Party last signing one of the counterparts.
- 22.4 The persons signing this Agreement in a representative capacity warrant their authority to do so.

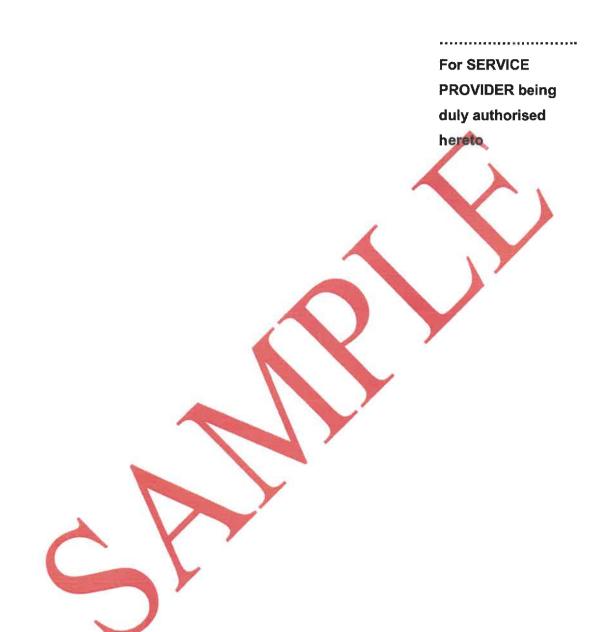

## **NOTES**

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if (applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

## **General Conditions of Contract**

#### 1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the

#### RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such

obligations of the supplier covered under the contract.

1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

## 2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

#### 3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from <a href="https://www.treasury.gov.za">www.treasury.gov.za</a>

#### 4. Standards

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

# 5. Use of contract documents and information; inspection.

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

## 6. Patent rights

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

## 7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
  - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
  - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

## 8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or

analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

## 9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

## 10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

## 11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

#### 12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

## 13. Incidental services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
  - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
  - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
  - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;

- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

#### 14. Spare parts

- 14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
  - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
  - (b) in the event of termination of production of the spare parts:
    - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
    - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

#### 15. Warranty

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take

such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

#### 16. Payment

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.

#### 17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

## 18. Contract amendments

18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

#### 19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

#### 20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

# 21. Delays in the supplier's performance

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the

supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

- 21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

#### 22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

## 23. Termination for default

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
  - (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2:
  - (b) if the Supplier fails to perform any other obligation(s) under the contract; or
  - (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any

person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

- 23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
  - (i) the name and address of the supplier and / or person restricted by the purchaser;
  - (ii) the date of commencement of the restriction
  - (iii) the period of restriction; and
  - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Anti-dumping and countervailing duties and rights
- 24.1 When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a
  provisional payment or anti-dumping or countervailing right is
  increased in respect of any dumped or subsidized import, the State is
  not liable for any amount so required or imposed, or for the amount of
  any such increase. When, after the said date, such a provisional
  payment is no longer required or any such anti-dumping or
  countervailing right is abolished, or where the amount of such
  provisional payment or any such right is reduced, any such favourable
  difference shall on demand be paid forthwith by the contractor to the
  State or the State may deduct such amounts from moneys (if any)
  which may otherwise be due to the contractor in regard to supplies or
  services which he delivered or rendered, or is to deliver or render in
  terms of the contract or any other contract or any other amount which

may be due to him

## 25. Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

## **26.** Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

## 27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
  - (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
  - (b) the purchaser shall pay the supplier any monies due the supplier.

## 28. Limitation of liability

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
  - (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

## 29. Governing language

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

## 30. Applicable law

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

#### 31. Notices

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

## 32. Taxes and duties

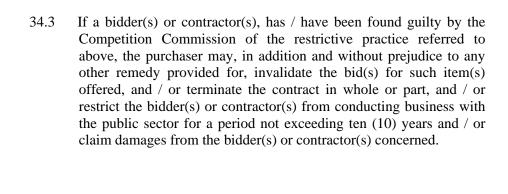
- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.

# 33. National 33.1 Industrial Participation (NIP) Programme

The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

## 34 Prohibition of Restrictive practices

- 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
